PLEASE READ CAREFULLY

The person, corporation, or firm whose name appears below acknowledges that it is able and willing to meet all commitments in regards to purchases made from Air Power, Inc. (Air Power) within the terms as set forth on invoices issued by Air Power. It is understood that this application is subject to approval by the Credit Department of Air Power and that extension of credit and/or limits thereof shall be determined solely by Air Power for the sole benefit of Air Power. Air Power reserves the right in its discretion to increase the customer's credit limit upon request by customer, but such increase shall not affect the other provisions of this agreement. All applications approved for credit are governed by the following:

- Should circumstances prevent extension of credit at any time, Customer agrees to accept "cash before delivery" (C.B.D.) or "cash on delivery" (C.O.D.) terms as determined by Air Power.
- An account which reflects a past due balance or will exceed an established credit limit may be subject to future shipments on C.B.D. or C.O.D. basis. Past due balances may be subject to a service charge of 11/2% per month (or the maximum rate allowable by law) and customer specifically agrees to imposition of this service charge on past due accounts. In accordance with the North Carolina General Statutes, the service charge may be imposed on payments received more than 30 days after the billing date; unless otherwise specified by the creditor, the billing date shall be deemed to be the date of the initial invoice for the shipment. Air Power also reserves the right to withhold shipments to customers whose credit accounts are past due.
- Any information provided by the customer is correct and were provided to induce Air Power to extend credit to Customer.
- Payments will be made in accordance with the terms so stated on each invoice.
- In the event of non-payment and the institution of legal proceedings, Customer agrees to bear the expense of collection, including reasonable attorney's fees, to the extent allowable by law.
- Advance notice will be given to Air Power of any change in the business structure relating to incorporation or changed ownership, etc. Without such notice, the original principals to whom credit was extended shall remain liable. Notice hereunder shall be given by certified or registered letter and acknowledged by return receipt.
- Credit policies are subject to change in the discretion of the Credit Department of Air Power. Upon acceptance of the application, and the issuance of an open line of credit, customer agrees to abide by the credit policies of Air Power.

The undersigned jointly and severally hereby expressly waive and agree not to assert any defenses either under the provisions of North Carolina General Statutes § 26-7 through § 26-9 as currently codified, or the North Carolina General Statutes as amended in the future, or any similar provisions of the laws of any other state or both. We agree that the liability assumed by each of us, individually and jointly, is primary, direct, unconditional, and enforceable without prior resort to said credit applicant; and same shall not be affected by any forbearance, extension of time for payment, settlement, composition, release or modification, express or implied, of the obligations hereby guaranteed. We individually and jointly waive demand for payment, notice of default, notice of protest or dishonor of or upon any and all obligations hereby guaranteed, and notice of amendment or modification or any such obligation. In the event we default in the due payment of our obligations hereunder, we agree to pay all costs of collection against us, including reasonable attorney fees, to the extent allowed by the law.
